Good afternoon District 35 Toastmasters:

The Credentials Report is as follows:

There are 70 eligible clubs in the district, and therefore 140 possible club officer votes (the club presidents and VPs of education). Needed for a quorum is 1/3 of this total, or at least 47 club representatives registered.

Between in-person and online registrations, 50 club officer votes were registered at the time of the meeting. Based on this, the meeting does have a quorum.

There were also 19 District Executive Committee members registered, who do not count toward a quorum. This gives a total of 69 total votes available.

35 votes represent a majority, and 46 votes represent a 2/3 vote.

Good afternoon, District 35 Toastmasters,

I am honored to be here today as the Finance Manager for District 35. While there remains room for improvement, District 35 is poised for a promising future. This optimism is owed to the collective efforts of all of you, our District Executive Committee, and the leadership of our esteemed Trio, District Director Jason Feucht, Program Quality Director Robert Wall, and Club Growth Director Theresa Flynn.

Thank you to the outstanding efforts of our Audit Committee: Chair and Past District Director, Ed Thelen, and members Mike Dill and Bethanie Gist, Distinguished Toastmasters all. Their time, dedication, and feedback on the mid-year Financial Audit ensure you can trust District 35 is managing funds appropriately.

Financial Report

Now, our Financial Report.

At our September Business Meeting, you may recall that Toastmasters International was behind in closing out monthly financial reports so our numbers were tentative. I am pleased to inform you that world headquarters is now current with their monthly closeouts and that our most recent financials are through March 31, 2024.

Checking Account Balance: \$23,671.18

District Reserve Available Balance: \$21,361.16

- Please note that \$6,859.07 of the available balance must remain in reserve with Toastmasters International
- This year, Toastmasters International reviewed each District's reserve per protocol 8.4.
 Section 3.B of the protocol states:

If the District reserve exceeds 1.25 times the Required Retention at the end of the program year, 50% of that amount shall be reduced from the District reserve and reallocated to Toastmasters International for purposes related to the organization's mission.

As a result, \$8,623.79 of District 35's budget was reallocated from our District Reserve Available Balance to Toastmasters International.

It is important to note that spending of District Reserves requires the approval of Toastmasters International during the annual budget process.

Total Available Funds: \$38,173.27

Total District Revenue: \$25,952.44

This is \$619.50 below our forecasted revenue

Total District Expenses: \$11,641.81

• This is \$9,236.01 below our forecasted expenses

As a result, our Net Income through March 31 is \$11,641.81. This includes \$4,853.69 in District Dollars earned by clubs.

If your club has district dollars, you are strongly encouraged to use them before June 30. District Dollars can be used to reimburse your club for anything that supports the entire club. If you have questions on reimbursable expenses, please contact me at <u>lisaelzpowell.d35@gmail.com</u>. All reimbursement requests should be submitted with a receipt through Concur.

There are numerous expenses still budgeted through the end of the year where money is planned to be spent in support of the District Mission. With continued club and membership building, and current planned expenses, the District is on track to be in alignment with the net zero net income planned for in our budget.

The Financial Report has been presented and will be filed for Audit.

District 35 Mid-Year Audit Report

April 27, 2024

The District 35 Audit Committee met on Wednesday, February 14, 2024. The audit committee is comprised of Chairperson Ed Thelen, DTM, PDD and members Mike Dill, DTM and Bethanie Gist, DTM. This report covers the period of July 1, 2023 through December 31, 2023.

The committee reviewed the documentation for financial income and expenses for the period covered above with respect to the following areas: organization, substantiating transactions, and policy review.

Overall, the recordkeeping was very good with supporting documentation for all expenses. Policies that are routinely commented on (sales tax and authorization of \$500 transactions) have been followed appropriately. Comments relating to budgets and compliance with policies in Concur were complete as well. The work of Finance Manager Lisa Elz-Powell, VC3 is most appreciated.

One system improvement that helped the audit was the ability of another Trio member to do the approval of expenses submitted by the District Director within Concur. While email documentation showing approval was also submitted, this is a great new check and balance within the system.

In the spirit of improvement that is a part of Toastmasters, the audit committee has a few recommendations to implement/consider:

Inconsistency in Financial Reporting Package Sent to World Headquarters and Audit Committee – The reporting package sent via email to the audit committee and World Headquarters from month to month. The list of the reporting package was sent to the District Finance Manager and Trio for the second half of the year.

Adding Notes in Concur when Supporting Documentation does not Equal Reimbursement Amount – With the advent of District Dollars, there are an increased number of expense reports in the Concur expense system where the amount of the report does not equal the amount listed in supporting documentation. While it is easy to assume that the difference is due to only having a certain District Dollars balance, this should be noted in a comment in Concur. The audit committee's recommendation is that the individual submitting the expense report should note this when creating the report and, if this is forgotten, the Finance Manager should add information in the comments.

<u>More Convenient Formatting for Registers Used in Audits</u> – Currently, the three registers to be provided to the audit committee for review are only available in PDF format. It would be helpful to the audit committee if these could be converted to another format (Excel) to provide the audit committee the ability to document their procedures more completely. We will be following up with this item for the second half of the Toastmasters year.

The audit committee also had a couple recommendations for either the District or for myself as Audit Committee Chairperson and a Past District Director to discuss with the Toastmasters World Headquarters staff.

Overall, District 35 is to be commended in its efforts to be financially sound and support the necessary policies for Toastmasters International to maintain its not-for-profit status.

Upon careful deliberation, the District Realignment Committee submits the following report and realignment proposal for the Toastmaster year 2024-2025 District alignment.

This proposal assumes:

- Our members will be better served with fewer area / division directors.
- Area contests next year (as we move back to in-person) will have a chance of being more meaningful with more clubs per area.
- We don't have an abundance of members who want to serve as Area and Division Directors.

Summary of this proposal

- Consideration was taken for clubs anticipated to charter prior to the end of this Toastmaster year.
- Consideration was taken to accommodate clubs potentially chartering in the next Toastmaster year, without creating an imbalance of areas/divisions.
- Most areas contain 5-6 clubs.
- Reduced Divisions from 6 to 5
- Reduce Areas from 19 to 17
- Solicited and received feedback from the DEC.

The Division E team has had a great year, with the goal of helping and supporting the clubs in Division E. The Eastern Division Area Director and Division Director teams have met on a regular basis on the 3rd Monday of each month as a Division (Area Director Team and Division Director team). This enabled us to collaborate as a leadership team in terms of our focus and efforts as we moved throughout the Toastmasters year. I want to give special thanks to the following Area Directors in the Eastern Division. Without the Area Director team, we could not be successful as a Division. I want to thank my fellow team members:

- Aaron Lau (E1)
- Carol Mather (E2)
- Paul Van Dyck (E3)

Thank you for all you have done and will do for your clubs, your areas, Division E, and District 35 this year.

Area Director Reports: A total of 7 (out of 13 total or 54%) Area Director Club visits have been completed. There are 2 of 13 visits scheduled and reports not yet completed (2 of 13 or 15%), there is 1 report of 13 or 8% that is marked as "report incomplete," and 23% or 3 area visits not yet completed. The final submission due date is 5/31/2024. The goal is to have all 13 club visits completed within the next 30 days or less.

Area 1: 3 of 4 Area Director visits completed (Aaron Lau) Area 2: 4 of 5 Area Director visits completed (Carol Mather) Area 3: 0 of 4 Area Director visits completed (Paul Van Dyck)

CONCERN 1 — AD VISITS: There are no immediate concerns in terms of Area Director visits. We had a concern back in Fall 2023 in terms of being able to connect with the Johnsonville Club, but that is no longer a concern. An Area Director visit was completed on 3/5/2024 for Johnsonville.

CONCERN 2 — **MEMBERS**: During the Fall 2023 report, we had concerns with 2 clubs that were below 8 members (Thriving Communicators and Water City Speakers). I'm happy to report that both these clubs have returned to good standing with at least 8 paid members. Water City Speakers has 8 members listed as active status; this was an effort that Carol Mather put a lot of time into, including an open house in early March 2024. Thriving Communicators Club has 9 members as of this reporting period. At the moment, Guardian Toastmasters in E3 has 6 members currently listed.

Membership numbers: Division E currently has 144 members across 13 clubs. This represents an increase of a net 10 members since the reporting period from Fall 2023.

There are 6 clubs with 12 or more members. 92.3% of the clubs (12 of 13) in Division E with 8 members or higher.

In terms of Club Officer reports, 100% of the clubs in Division E have their Club Officer listing submitted (13 of 13).

4 clubs had at least 4 club officers or more trained through the Club Officer Training sessions during the Winter session. A special shout out to NEW After Hours Toastmasters with 7 club officers trained and Talk of the Town with 6 club officers trained!

Membership will continue to be a focus moving forward. The membership numbers did increase between Fall 2023 and Spring 2024 with a net increase of 10 total members.

I also want to thank Jennifer Kibicho, Immediate Past District Director, who was kind enough to visit three clubs in Area F3 in Fall 2023 and submit club visit reports while we were seeking an Area Director.

Together, you showed commitment to helping all clubs achieve excellence by visiting them well ahead of the November 30 and May 30 deadlines. Your efforts help our District leadership team understand each club better and identify ways to support them in reaching their goals. In addition, each of you helps your area be one step closer to becoming Distinguished and, in turn, helps our District become Distinguished.

Division F has 15 clubs. The oldest, Allis Chalmers Toastmasters, charted on 1/1/1950, and the newest Speak-On, chartered on 3/1/2024. Among the clubs, there are a dinner club, a club that meets on Sunday morning, a club that fundraises at the WI State Fair, and a club that has a "Toastmasters Educational Minute" to educate everyone about all aspects of Toastmasters so that newer members can better understand more about the organization. Since July 1, 2023, every club has shown excellence, be it through club officer training, earning education awards, competing in speech contests, volunteering in the community, offering a Friday Night Fun Night, and everything in between.

I would like to share highlights of membership, speech contests, officer training, education awards, and the Distinguished Club Program as of April 19, 2024.

Membership

Division F has 148 renewal payments (through 4/19/2024) on the books, and our clubs have brought in 51 new membership payments since the start of the Toastmasters Year.

Speech Contests

Members from eight clubs across the three areas competed and three members (one from Area F2 and two from Area F3) competed in both International and Evaluation area contests. All three areas had both International and Evaluation contests. Division F will have a contestant in both contest types at the District level. Contestants shared stories of resilience, strength and courage through their International contest speeches. They also shined in evaluating test speakers who are on opposite ends of their Toastmasters journey. Finally, the clubs' commitment extended to taking on contest functionary roles, be it for the umpteenth time or the first time. There was one member who served as Zoom Master at the Division F Contest for the first time and did a fabulous job. Members also served as contest functionaries at other Area and Division Contests (not in Division F).

Club Officer Training

Division F clubs have shown commitment to continuous learning by attending the winter officer training. The focus of winter training was progress, not perfection. Clubs exchanged ideas on what works, and what does not, and left with at least one idea to try.

- One club (The Breakfast Club) had 7 of 7 trained in both summer and winter periods.
- Thirteen clubs had at least 4 officers trained in both summer and winter periods.

My challenge to every club is to strive to train all seven officers in summer and winter. That is an uncomplicated way to build trust among the club members. Share what you learn at these training sessions with all members and set the right tone and model behavior for them to follow.

Education Awards

Collectively, clubs have earned 51 educational awards since 7/1/2023. Three members earned a Triple Crown-achieving three (or more) education awards in a single program year, Two club members are club coaches. Congratulations to all of you! Please continue to support and nudge each other. One way to do this is to give members a chance to be involved within and outside of the club by focusing on their strengths and then asking them to stretch themselves. When members feel supported, they will be even more impressive and our District will see a continuous inflow of leaders.

Distinguished Club Program Goals

I am pleased to share that Racine Club has earned the "Distinguished" status. Yay! Six clubs are "Almost Distinguished," each needing only more members to become Distinguished. Area F2 needs one more Distinguished club to become a Distinguished Area. There are still two months left in the Toastmasters year Continue to work together to identify opportunities and seek support from your Area Director.

In closing, I encourage all clubs to keep it going and look ahead to next year by taking small, simple steps, to help themselves.

- Conduct officer elections in May and submit the list of incoming officers by the end of May.
- Create a transition plan from the outgoing club officer team to the incoming club officer team.
- Give the speech that earns your club one more educational award.
- Mentor a new member.
- Continue to respond to guests' inquiries promptly and make the first meeting memorable.
- Ask guests to join your club: "We would love to have you join our club!"
- Identify your club's culture, top three strengths, and niche.
- Pair club members who have the same path (and level).
- Encourage members to ask questions of each other; someone may know the answer.

The actions you take and the skills you build will lead to greater self-confidence and personal growth that we all need to thrive and make a positive difference in each other's lives.

Thank you for the opportunity to serve District 35 as the Northern Division Director.

I'd like to begin by thanking the Northern Division team for their leadership and their support for the clubs in their area. Jeff Gut is the N1 Area Director and Kathy Shine is the N3 Area Director. The N2 Area Director position has been open nearly all year, and several people have stepped up to fill in the gaps. My thanks go to them as well.

The Rasmussen College Toastmasters voted to change their name to the Wausau Evening Toastmasters, reflecting the fact that they no longer meet on the campus of Rasmussen College in Wausau. Area N1 now has the Wausau Morning Toastmasters Club and the Wausau Evening Toastmasters.

Also in N1, the Marshfield Area Toastmasters voted to fold, effective April 1, 2024. All the members of the Marshfield club except one were already active members of at least one other Toastmasters club; this was the primary reason that the club voted to close.

The Northern Division has 129 members across thirteen clubs. Like other Divisions in District 35, some of our clubs have seen growth while others have lost members. I'd like to give special recognition to the Wausau Morning Toastmasters Club, which has more than doubled its membership this year from a base of five to eleven members currently. We challenge every other club in the District to match this level of growth. Very impressive, Wausau Morning Toastmasters!

Collectively, Northern Division Toastmasters have earned 36 Distinguished Club Program Goals, led by the Royal Toastmasters with seven goals, the Wisconsin Rapids Area Toastmasters Club with six, and the Church Mutual Club with five. The Church Mutual Club has already attained Distinguished Status, and the year isn't over yet.

Redistricting will affect the Northern Division and its component Areas as much as any Division in the District. The Northern Division is by far the largest geographically, and the new maps expected to be adopted will increase the geographical area of the Division. However, as most clubs meet in a hybrid or virtual environment, it's possible to connect with clubs located far away. If you're interested in serving as a club coach or Area Director, don't let geography stop you. In situations where an in-person presence is required, such as Area Director visits for clubs that only meet in person or in-person speech contests, the members of the Northern Division have a long tradition of stepping up to help out wherever needed.

It is a pleasure to submit my Annual Report as your Immediate Past District 35 Director. Being out of the country has limited how much I can be involved in the District. However, with advancements in technology, I have been able to do my part in supporting our District to achieve its mission: building new clubs and supporting all clubs in achieving excellence.

I will summarize four key activities that I engaged in this year.

One:

In the first quarter, under the leadership of Division F Director Yuriy Ksenidi, I visited three clubs in Area F3: The Breakfast Club, SpeakEasy Toastmasters, and Long Story Short, which did not have an Area Director assigned. The decision to conduct the Area Director visits was informed by a strong belief that no Club should be left behind and that all clubs in our District must be served, whether or not they have an Area Director. I am pleased that we now have an Area F3 Director, and that all 3 clubs, and indeed all clubs received an Area Director Visit in the May cycle. Making those Area Director visits have reinforced the importance of clubs getting outside perspective in how they can recruit new members and retain existing members so that our members get value for the \$0.33 a day investment in Toastmasters membership.

Two:

Collaborated with 2 Club Coaches to support an existing struggling club. I am pleased to announce that the club added 5 new members this year and had 5 club officers trained in the Summer and 3 in the Winter. The Club Coaches are working with the club leadership to ensure that April renewals are submitted so that the club can remain in good standing.

Three:

The quarterly District 35 articles dubbed as Immediate Past District Director Reflections. So far, I have published 2 articles and have 2 more to go!

Four:

Supporting my home club through consistent attendance at each club meeting. Given that I am located 9 hours ahead during Daylight Savings Time and 8 hours ahead during Daylight Standard Time, being part of the club meetings, including taking on my role as VPE, has meant that I wake up at 3:00 am to attend a meeting. That consistency in club attendance, with a core team of Toastmasters, has provided stability to our club, and seen several guests attend and some choose to join Toastmasters. In this regard, I would like to thank the Division **F** Director for initiating joint meetings between our clubs that have helped to revitalize our respective clubs.

As I finalize my report, I would like to thank you all for the privilege of serving in District Leadership in the last four years. My invitation to you is: Let us recommit to the Toastmasters Promise by holding onto the baton, and ensure we pass it safely to the next generation of leaders. This has been the year of opportunity. We've seen the signs that people are coming back to investing in themselves and getting out into the community and we're ready for them as we work toward our three quantifiable goals for Distinguished Districts: member strength, education (from distinguished clubs), and club building.

This year we started strong. Forty clubs took advantage of Renewal Rush helping to bring clubs into good standing before October and three clubs worked to get to eight members so they were in good standing by at the end of the next dues period. We chartered one new club in March — Welcome Speak-On, a corporate club at Snap-On in Kenosha.

As of March 31, we were 32nd worldwide for club growth and retention and the upper 50% for membership growth and retention. We were 2nd in our region for club growth and retention.

After the past five years of losing about 10 to 18 clubs per year, on March 31, we were down by a net of only one club. After losing up to 450 members in a year in the past few years, on March 31, with three months to go, we were down by about 270.

And then on April 1 with the new dues period, we were down by 22 clubs and 228 payments.

District 35 is still ranked 4th in the region for club growth and retention and in the middle of the pack for payments, but 22 clubs did not hit the minimum 8 members by April 1.

Of those 22 clubs, two were not a surprise. In the past few weeks, a few clubs have pulled in additional payments, either late payments for existing members or some of the 48 new club members for April 1. Of the others, 9 clubs need just one or two members.

We have just over two months until the end of the year, and this year is the closest we've been to distinguished for members or clubs in over six years.

If each club can pull in three or four new members by July 1, we will have that leg of distinguished handled. Reach out to guests, reach out to past members. Corporate clubs: reach out to your employee resource groups and other departments. Publicize your clubs. We have training videos on the website on finding and creating posters and social media images, MeetUp for all community clubs, and we are working on encouraging clubs to attend farmers markets in their communities to get the word out that Toastmasters is a great place to learn skills and meet neighbors. Another leg of that distinguished triad is in club creation. So far, we've chartered one club. We are working on three virtual clubs as well as physical clubs in Milwaukee, Madison, Kenosha, and Green Bay. Supporting new clubs is part of earning the Distinguished Toastmaster (DTM) designation and it's a great way to help develop a new club culture – helping mentor new officers and attending club meetings gets you out of the comfort zone of your club to see new options and opportunities and to meet people you may not have otherwise. You win with experience and expanding your network, and the club wins with an experienced Toastmaster supporting their goals. Contact me to become a club sponsor or club mentor or if you'd just like to take on a few roles in a new club. We need to get at least two of these clubs up to charter strength before July 1.

Some activity asks through June 30: I'm here to support your club if you have questions, and I'll spearhead new clubs. And your role in getting us all to distinguished:

- Give a Pathways speech (be sure to mark it complete in Base Camp).
- Invite guests to your club to watch you improve.
- Publicize your club on social media and through traditional bulletin boards and community events
- Volunteer to support new clubs, either for DTM credit or because it's fun.

Hello, fellow Toastmasters!

It seems like yesterday when we started this year, but we're already ten months in. Time definitely flies! First some quick updates.

Due to the hard work of our TLI Dean Cindy Laatsch, the Division Director Team, and our district PRM Teri McGregor, this winter we planned and promoted four quality training sessions. We were on par with previous years in terms of officer participation, having 62% of our clubs with 4 or more officers trained in the winter cycle. As a reminder, TLI attendance is one of the single biggest predictors of club success, so it's exciting that we're maintaining interest in the winter session.

We're about to wrap up our contest season a couple of hours from now. Due to somewhat lackluster participation numbers in the post-COVID years, this year my goal was to bring back a contest that was more accessible to new members – the Evaluation contest – in the hopes of drawing in more people. The number of participants was still lower than I'd have liked, but the overall quality of the speeches was very good. We've also identified some opportunities for future training and reinforcement for next year as we rediscover the process of running 100% in-person contests.

So where are we now?

In the fall I indicated that we were starting to reverse the downward trends from the past few years. And with two months left, it's looking like we have a reasonable shot at being a distinguished district.

Let me start with some stats.

We have around 250 members that have been around for longer than 10 years. We also have about 500 members that have been around for two years or less, and 350 of those members have been around for a year or less. The median membership length in our district is just over 3 years. About 15% of our district isn't enrolled in Pathways, with the majority of that 15% being from the 500 members that joined in the last two years.

With me so far?

I want you to think for a minute how challenging it can be to get a guest to a meeting and get them to join. I think we can all agree that it's much harder to find a new member than it is to retain an existing one, and that all revolves around the member finding satisfying success via the Toastmasters program.

Fortunately, that success – even though it depends heavily on them – is still largely within our control. And their success drives your club's success, which in turn drives the district's success. So, let's talk about how we achieve that success.

First, if a member isn't enrolled in Pathways, they're not doing the education program, they're not getting the value they should be out of their membership – the value they're paying for – and they're even more likely to quit. If you know anybody in this camp, I encourage you to encourage them to choose a path and give their icebreaker. Let's work hard to get that 15% down to zero.

Second, many of those 500 members who joined in the last two years don't understand club leadership, district leadership, or even that simple things like taking meeting roles are developing real-world leadership skills. I encourage you to talk with one of your new members about how they can get the most out of the Toastmasters program by pursuing these opportunities.

Third, for those of you who are fortunate enough to have a solid club culture where people are actively participating in Pathways, volunteering for meeting roles, and stepping up for club-level leadership, we can drive even more value by educating these members that the next step is to go outside the club and volunteer for a role like Area Director. District leadership isn't for everybody, but in your club, you can see the people who would benefit from challenging themselves and reaching outside the club. You can encourage them to reach for the next level and be the catalyst for their success.

If we get good at these things and by positively encouraging our members – especially our new ones – to take the next steps and find value in the program, we're laying the foundation for our future success at both the club and the district level.

And if we do this exceptionally well, many of those 500 new members will be the ones driving our district's success in another 5-10 years.

We have two months left, and we have our work cut out for us this year, but I know we can do it. I encourage all of you to strengthen your focus on driving value for your members and be on the lookout for a new incentive program coming out in the next couple of days to give your club some positive encouragement for making that final push as June 30th approaches.

Of course, if you have challenges, let us know how we can help. Reach out to your area or division director or call me. My door is always open. Here's to an awesome two months and beyond!

District 35 Toastmasters:

I want to again thank you for the honor and opportunity to serve this year as your District Director.

It's amazing to think that it's already the end of April and that the end of our Toastmasters year is just two short months away. Today, I want to challenge us to work together to reach the finish line and beyond.

From a numbers perspective, we are closer than we have been for several years to meeting the goals Toastmasters has set for us as a District. This year we celebrate Toastmasters International's 100th Anniversary and <u>Our Time is Now</u>, to shift from the struggles of the past to a trajectory for growth and a positive future.

When I look across the District and our clubs, there are, of course, struggles – there always will be. However, there are also many great things going on. We heard about many of them at our Awards earlier, and we will hear about more later at the Hall of Fame.

The District Executive Team continues to work hard to accomplish the District Mission: to build new clubs and support all clubs in achieving excellence, with *Integrity, Respect, Service, and Excellence*. As I prepare this report, we have 68 of our 83 clubs in good standing, seven clubs already Distinguished out of the goal of 34, and as a District, we are about 235 member payments away from our goal. I'm confident that if we continue to work together, we can get there.

To support our efforts at membership growth, I wanted to share some details about the District's participation in the Toastmasters International LinkedIn Advertising Campaign. This is an optional program for Districts to support our clubs. This year is the first year we participated in this program to augment our own LinkedIn Campaign. The three-month program was administered by World Headquarters and ended just a few weeks ago. According to the statistics we received, the campaign resulted in over 234,000 impressions in Wisconsin and Upper Michigan on LinkedIn, over 1,200 click-throughs resulting in over 170 prospective members completing the Find-A-Club form during the campaign. This is an important step the District has taken to support our club's membership growth. However, as we all know, the best member growth is still organic through positive club experiences and efforts in our clubs.

When I spoke before this group in the fall, I talked about two ideas. Those ideas I would like to put back out there for you to consider again now, for the rest of this Toastmaster year and into the future: Be Solution-Oriented and Do Your Best. It's very easy when things get challenging or overwhelming to focus on the problems and what's wrong. "So-and-so" did "such-and-such," that whatever the issue is would be better if people just did things "right," or that there is a "magic" solution somewhere out there that someone has and is keeping from you. I encourage us all not to fall into those traps, as negativity builds more negativity. Focusing on the possible builds possibility. Taking ownership of our actions and doing our best to help our members, each other, and to learn and grow as Toastmasters helps us all. Building new clubs, bringing new members into existing clubs, and working through the Toastmasters education program <u>helps us all</u>. Not one of us can do these things alone; collectively, we must work together.

Toastmasters instills these ideas in all of us through our Core Values but also through the Toastmasters Promise. I believe the idea of being solution-oriented and doing your best is very much in alignment with the Toastmasters Promise. Every one of us, when we completed our membership application, agreed to the Toastmasters Promise. Do you remember any of the ten points of the Toastmasters Promise? I challenge all of us to take a moment in the next week and review the Toastmasters Promise as we reexamine ourselves and see what opportunities we each have, myself included, to better fulfill that promise and our personal commitment to ourselves to develop through Toastmasters.

Do your best and be solution-oriented. If your club is short members, bring along someone you know who could benefit from Toastmasters. If your club needs meeting roles filled and speaker slots filled, sign up. If your club needs another education level to get help on their path to distinguished, finish that level. If your club needs a club officer, lean in, and try it. Finally, if you are afraid to speak, or like me right now, nervous EVERY time you speak, try it.

Toastmasters is a Learn by Doing Organization, and I encourage us all to Learn and Do through focusing on solutions and doing our best.

I'm very proud of all we have done, continue to do and of all of us here in District 35, I'm confident we will be successful. Let's draw the line here and leave the struggles of the past behind us to make this the most successful year in recent memory. Let's live the Toastmasters Promise to get to the finish line and beyond. Our Time is Now because Together as Toastmasters we are all Stronger.
